## 2007 ECAC Men's East All-Academic Teams Announced

**Cape Cod, Mass.** -- Interim Commissioner of the ECAC, Stephen R. Bamford, is pleased to announce the 2007 ECAC East Ice Hockey All-Academic Team. This marks the fifth year that the conference has named an all-academic team; a total of 36 student-athletes representing nine of the 10 ECAC East teams earned this honor based on outstanding performance in the classroom.

To be named to the all-academic team, the student-athlete must have completed at least one academic year, have a cumulative grade-point average of at least 3.00 on a 4.00 scale, and have competed in at least one-half of his team's contests during the current season (the goaltender must have played at least 33 percent of his team's minutes).
